**FLAG GUIDELINES**

1. No more than one (1) freestanding permanent flagpole per home is allowed.
2. No more than two (2) wall mounted or portable flagpoles per home are allowed.
3. Flagpoles must be installed in a professional manner<sup>1</sup> and be kept in "like-new" condition<sup>2</sup>.
4. Freestanding permanent flagpoles must be no more than twenty (20) feet in length and no more than four (4) inches in diameter. Wall mounted and portable flagpoles must be no more than seven (7) feet in length, no more than two (2) inches in diameter.
5. Flagpoles must be circular in cross-section, and be constructed of either aluminum or stainless steel. Wall mounted and portable flagpoles may alternatively be made of wood.
6. If the flagpole is painted, the entire flagpole must be one uniform color. Acceptable colors are metallic silver, metallic gold, white, or black.
7. The flagpole and flag display are subject to all building codes, zoning setbacks, and other applicable governmental regulations, including, but not limited to noise and lighting ordinances.
8. The flagpole must not obstruct sight lines at street intersections, and must not be located within or upon an easement.
9. Flagpoles shall not be placed in the area between the public sidewalk and the street.
10. Flagpoles must be set back a minimum of twenty (20) feet from the edge of any street, a minimum of ten (10) feet from the edge of any public sidewalk, and a minimum of ten (10) feet from any adjacent property.
11. No more than four (4) flags per home may be displayed at any time.
12. No more than two (2) flags may be displayed from a single flagpole at any time.
13. No more than two (2) portable flags per home may be displayed at any time.

Flag Guidelines continued...

14. The maximum size of any flag is four and one half (4.5) feet by six (6) feet.
15. Acceptable flag designs are the official flags of the United States, the State of Florida, the United States Army, Navy, Air Force, Marines, or Coast Guard, or a POWMIA flag. Novelty flags are allowed, provided they are in good taste.
16. If the United States flag is displayed with an additional flag, then the United States flag must be mounted above such additional flag. Such additional flag must either be equal in size or smaller than the United States flag.
17. Flags are to be displayed in a respectful manner and be in "like-new" condition<sup>2</sup>. Display of the United States flag must be consistent with Title 36 U.S.C. chapter 10.
18. The Board of Directors and the DRC reserve the right to have any flag removed if they deem them to be not in harmony with or appropriate for the Woodfield Community.

<sup>2</sup> Having the appearance of new. Subject must not show signs of excessive wear or deterioration. Maintenance may be required in restoring or keeping of the original aesthetic condition.
