ARTICLE XIX, OF THE BY-LAWS IS AMENDED TO READ AS FOLLOWS:

### ARTICLE XIX ALTERNATIVE DISPUTE RESOLUTION

#### EINES

The Association shall have the authority to levy fines for violations of the By-Laws, the Declaration of Covenants and Restrictions and Rules properly adopted by the Association. The board shall have the authority to promulgate rules to maintain the integrity of this provision and implement to the terms hereof.

The Association may suspend, for a reasonable period of time, the rights of a member or a member's tenants, guests, or invitees, or both, to use common areas and facilities and may levy reasonable fines, not to exceed \$100.00 per violation, against any member or any tenant, guest, or invitee. A fine may be levied on the basis of each day of a continuing violation, with a single notice and opportunity for a hearing provided that no such fine shall in the aggregate exceed \$1,000.00.

(a) A fine or suspension may not be imposed without notice of at least 14 days to the person sought to be fined or suspended and an opportunity for a hearing before a committee of at least three members appointed by the board who are not officers, directors, or employees of the Association, or the spouse, parent, child, brother, or sister of an officer, director, or employee.
