AMENDMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR WOODFIELD

The following is an amendment to the Declaration of Covenants and Restrictions for Woodfield, originally recorded at Official Records Book 6286, Page 675, et. seq. Public Records of Pinellas County, Florida, and as subsequently amended.

New Wording <u>Underlined</u>; Deleted Wording <u>Stricken Through</u> (Except when proposed amendment involves substantial rewording).

Declaration Article IX, Section 25 is **created** to read as follows:

- Section 25. Renting/Leasing. All leases or occupancy agreements of Lots (collectively, "Lease Agreements") are subject to the provisions of this Section. For purposes of this Declaration, "leasing" is the exclusive occupancy of a Dwelling Unit or Lot by any Person other than the Owner, for which the Owner receives any consideration or benefit, including, without limitation, a fee, service or gratuity.
 - (a) All Lease Agreements shall be in writing, shall include a signed Uniform Lease Addendum form (form to be created by the Board) and shall be provided to the Association at least 15 days before occupancy.
 - (b) No Lease Agreement may be for a term of less than five (5) months and 29 days.
 - (c) A Lot may not be rented more than three (3) times in any calendar year.
 - (d) The restrictions in this Section shall not apply to the Association in the event it takes title to a Lot by foreclosure or deed in lieu of foreclosure.
